Tax Credits for Clean Energy

- Federal Residential Clean Energy Credit, taxpayers' who invest in renewable energy for their homes may qualify for an annual residential clean energy tax credit. The credit equals 30% of the costs of new, qualified clean energy property installed any time from 2022 through 2032. **[Residential Clean Energy Credit | Internal Revenue Service \(irs.gov\)](#)**
- Massachusetts Residential Energy Credit: taxpayers can receive a tax credit for certain renewable energy improvements made to their primary residence. Eligible households can receive a credit of either 15% of the cost of the solar panel system, or up to \$1,000. Please also be aware, all solar panels and eligible installation equipment are exempt from state sales tax. **[Massachusetts Residential Property Tax Credits | Mass.gov](#)**

Mass Solar for All

Although the program is not yet available, you can visit **[Solar For All and Affordable Housing \(mass.gov\)](#)** for a brief overview. Massachusetts has received funding to expand access to solar for low-income and disadvantaged communities. At this time, the program design includes two options for installing solar on homes with 1-4 units. (1) 0% interest loans where homeowners will directly own the solar panels and can apply for solar tax credits, or (2) grants to support leasing solar panels (the property owner would not be to apply for the solar tax credits).
